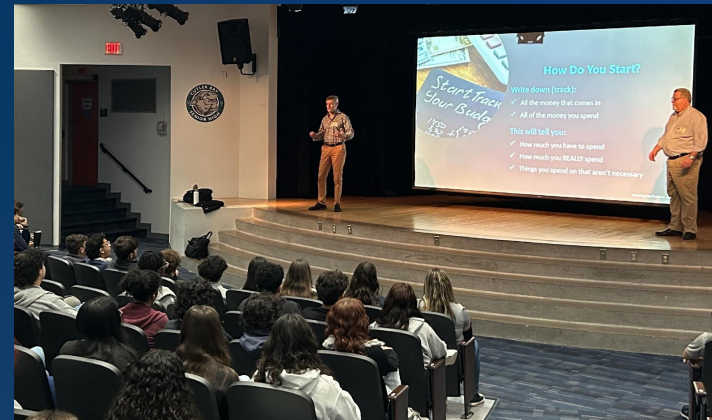
The Bankruptcy Bar Association of the Southern District of Florida
