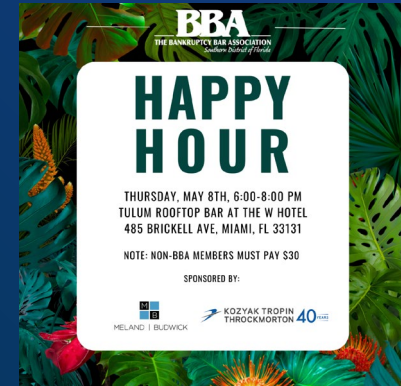
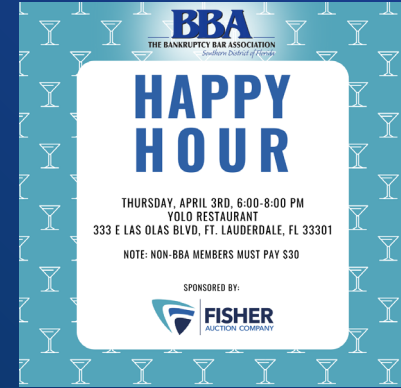

HAPPY HOUR, COMMUNITY OUTREACH, & WELLNESS EVENTS GUIDELINES FOR BBA SPONSORS

- For **Diamond, Emerald, and Platinum** sponsors:
 - Events will be **exclusively hosted** and these sponsors will have first priority in selecting a venue and location.
- Gold, Silver, and Bronze sponsors will be on a first-come, first-served basis:
 - Events may be **co-hosted** by 2 or more sponsors
 - Sponsors will respond to an online form indicating preference for Miami, Fort Lauderdale, or West Palm Beach
 - Sponsors will select preferred venue from list
 - Sponsors will select preferred date from list
- The BBA will match dollar per dollar the cost of the happy hour up to \$750.
 - The sponsor will be responsible for any amount greater than \$1,500.
 - For example, if the total happy hour cost is \$1,600, the sponsor will pay the first \$750, which will be matched by the BBA with another \$750, and the sponsor will then have to pay an additional \$100.
